Republic Act 7160 otherwise known as the Local Government Code of 1991, section 80, for the purpose of filling up vacant positions in the Office of the Sangguniang Panlalawigan, a Personnel Selection Board (PSB) for the said office is created.

Section 12, (14), Chapter 3, Title I (A), Book V of the Administrative Code of 1987 provides that the Commission shall take appropriate action on all appointments and other personnel matters in the Civil Service.

Where, CSC MC No. 40, series of 1998, dated December 14, 1998, the Commission prescribed the Revised Omnibus Rules on Appointment and Other Personnel Actions. However, certain provisions thereof were amended through various issuances of the Commission.

Hence, in response to the changing needs in human resource management, there is an urgency to update and consolidate the various issuances on appointments and other human resource actions to facilitate action on all kinds of appointments and further simplify processing thereof.

The Commission, pursuant to CSC Resolution No. 1701009 dated June 16, 2017, adopts and promulgates the 2017 Omnibus Rules on Appointments and Other Human Resource Actions to govern the preparation, submission of, and actions to be taken on appointments and other human resource movements.

The Sangguniang Panlalawigan of Quezon hereby reconstitute the **SP-PSB** as follows:

Section 1. Name. Sangguniang Panlalawigan of Quezon Human Resource Merit Promotion and Selection Board or SPQ HMRPSB.


